ORDER

An OBJECTION TO STIPULATED ORDER FOR PERMANENT INJECTION AND MOTION TO CLARIFY has been filed by GREENSKY, LLC. It is the Order of this Court that GreenSky, LLC cooperate with the subpoena issued by the Receiver in this case as it relates to customers obtained by GreenSky through American Plumbing and Septic Service that is the subject of the Preliminary Injunction.

Additionally, those customers payments will be suspended for sixty (60) days from the date the Receiver obtains that information requested in the subpoena. That will give the Receiver time to verify what loans are valid and those that are not. The Receiver will notify the Court and GreenSky upon completion of his investigation of all loans and his determination as to their validity. All valid loans will resume payments and those that are suspected of being fraudulent will be addressed by the Court at a later hearing. No interest shall accrue on loans during this period.
